4. What is your position on strengthening protections for Caribbean immigrants within the County?

I have always been a strong ally and advocate for our immigrant communities within Prince George's County. I have stood with immigrant taxi drivers who were taking on the powerful cab companies, and I have earned the support of CASA in Action because of my work on behalf of immigrant communities. Going forward I will remain a staunch advocate for Caribbean immigrants and all immigrant communities.

5. Would you support introducing books by Caribbean authors into the Public School system and county libraries?

Yes I am highly supportive of efforts to introduce books by Caribbean authors into the school and library systems. Children of all backgrounds must see themselves reflected in books, media, and popular culture.

6. In 2012, Governor Martin O'Malley created the Governor's Commission on Caribbean Affairs. The mission of the group was to expand outreach, ensure greater access, and serve as a resource to increase the economic, educational, health, political, and social well-being of the Caribbean community in Maryland. Unfortunately, no funding was provided to institute such programs. Can we count on you to demand that the Commission be reestablished, and the necessary funding appropriated to fulfill the mission?

Yes, I will be supportive of the effort to re-establish and allocate the necessary funding to institute the programs created by the Governor's Commission on Caribbean Affairs.

7. It is difficult to balance crime prevention and community safety with trust and improved relations with local law enforcement. How will you work to strike this balance?

During my prior service on the County Council, I did several things to strengthen both public safety and relations between law enforcement and the community. I conducted community walks throughout all of the District 3 neighborhoods to bring residents, police, and other agencies together. We formed several civic associations and strengthened community relations as part of this effort. In addition, I convened a county-wide youth and gang violence prevention task force which included schools, nonprofits, police, parks and recreation, and other
